- b. Over-writing is not allowed. Please make sure the form is filled as neatly as possible. Applicant will be responsible for any mistakes/ommissions.
- c. Wherever small choice boxes are provided in the form the box adjacent to the appropriate answer is to be mark "X".
- d. Signature or, if illiterate, thumb impression of left hand of the applicant is required (Parent/guardian(by providing ID# on right side of box) may sign in case of inability on part of the applicant).
- e. NIC/CNIC/NICOP/POC number are to be written/entered without dashes.
- f. Get the form (complete in all respects) attested and provide 2x recent photographs out of which one photograph fixed on the form signed across by applicant and attester in case of form based booking. For NIS booking only attestation on the form is required. Any adult CNIC/NICOP/POC holder other than referenced relative can attest the form.
- g. In case of NONE HOME DELIVERY, your card will be sent at the concerned Pak Mission Abroad/Embassy/NADRA office or Card Distribution Point.
- h. **Fee for processing of Pakistan Origin Card (POC) is applicable as per prevailing fee structure.** Detail is available on NADRA website (www.nadra.gov.pk) and with NADRA offices and Pak Embassies/Consulate/Missions.

Note: You should inform NADRA in writing along with this form, if you are/were a citizen or national of an independent state or country comprising any of the territories included in India on the 31st March, 1937.

DOCUMENTS REQUIRED:

- 1) **Bank Receipt / Draft**
- 2) **Two Recent Photographs (1.5" x 2")**
- 3) **Attested Photocopy of Foreign Passport (Non-Expired)**
- 4) **Applicant's Pakistani ID like CNIC, NIC, Passport etc OR any of Parents / Grand Parents Pakistani ID and document(s) to show link with parent/grand parent like Birth Certificate, Educational Documents etc and any Pakistani Living Relative's ID with statement OR Attested copy of marriage certificate, Pakistani spouse's ID with his/her declaration/Affidavit**
- 5) **Attested Marriage Certificate only for female applicants (if CNIC/NICOP/Pakistani Passport was not issued with husband name)**
- 6) **Original CNIC/CRC or NICOP (If Held).Applicant will have to apply for cancellation of CNIC/CRC/NICOP prior to processing of POC application if age is greater than 21years. Affidavit for Single National (attested by Pakistani Embassy/Consulate) and Renunciation Certificate is required from Dual National**
- 7) **Any other document may also be required for verification purpose**

INSTRUCTIONS ON INDIVIDUAL FIELDS:

- a. Types of application (Field 1): Applicant must mark "X" only one choice.
- b. All Names (Fields 4 to 19 where applicable): If any of the name is larger than the space provided, you MUST abbreviate it appropriately as you would like it to appear on the card and should **not exceed twenty seven (27) characters** in any case including spaces.
- c. NIC number (Field 2 to 29 where applicable) All numbers must be written without dashes, leave unused **Blank** spaces
- d. Date of birth (Field 27): Year of birth is mandatory. In such cases day and month will be considered as 1st January.
- e. E-mail (Field 31): Provide your E-mail address or of any relative.
- f. Field (29-30): Relative information is compulsory only for category "a" and "b" if opted in FIELD 3 and applicant has origin of East Pakistan or applicant's parents are deceased or non of them is Pakistani Citizen at present.
- g. **For Home delivery abroad foreign Phone No. and Zip/Postal Code in foreign addresses wherever applicable are required.**
- h. Photo, Thumb and Signature MUST not exceed allotted space otherwise it will be truncated. Photo with eyes open and clearly visible (without glasses), and no hair across the face or eyes
- i. Fill out payment details in (Field 41) and attach original deposit slip/bank draft.
- j. For Modification/Change in already issued POC, please highlight the field (s) which you want to modify.
- k. Left hand thumb impression is mandatory to be fixed in the "Applicant's left thumb impression "box" in (Field 35).

I being Pakistani Spouse of the applicant, own the responsibility of reporting to NADRA for cancellation of POC in case separation/divorce is effected.
